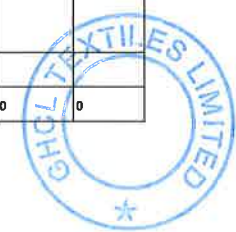


GHCL Textiles Limited: Shareholding pattern as on September 30, 2024

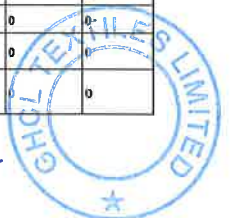
